**INDIVIDUAL DRESSAGE TESTS** \$20 per test. Individual tests will not be used as part of the dressage highpoint scoring.

- Sashes to sixth place in all Sections.
- Champion & Reserve Sashes for Dressage Highpoint in each section
- The Maximum number of tests one horse can compete in is 4.
- All tests may be called. (Only the printed text or extracts thereof are permitted to be read out. No other form of assistance may be given. The caller may read each movement once or twice only. Failure to observe this rule may entail elimination.)

### CONDITIONS OF ENTRY

1. Entering this competition constitutes acknowledgement that PCAV rules apply and acceptance of these rules.
2. All OPEN riders fill in the [Liability Declaration Form](#)
3. \$10 Day Attendance Fee is due UNLESS you are a financial member\* of EV/EA; AHS; SHCA; HRCVA; PCAV; AERA; an Interstate Pony Club; or can prove personal Liability Cover of at least \$10,000,000. \*Must produce proof. (Not personal Medical) and complete the [Day Participant Waiver](#).
4. PCAV club member cards must be inspected at the secretary's office.
5. PCAV members may ride in either Pony Club or Open Section or both as per PCAV Handbook of By-Laws
6. Competitors may ride more than one horse competitively, subject to ballot of entries. Preferences will be based on entry order.
7. Competitor numbers will be allocated by the organising committee. Bridle or saddlecloth numbers must be provided by competitors.
8. No refunds after closing date except with vet or medical certificate. An administration fee of \$10 will be deducted.
9. The organising committee reserves the right to cancel any class or competition; divide any class; alter times; refuse any entry with or without stating the reason.
10. Horses must be at least 4 years old, no stallions, colts or rigs.
11. Gear check is required for all riders prior to 1<sup>st</sup> dressage test and after any change of gear, Competitors who do not comply will be eliminated. PCAV gear rules apply.
12. Medical Armbands must be worn by **ALL COMPETITORS**.
13. Full Pony Club uniform to be worn. Open riders may wear jackets or HRCVA uniform, Pony Club uniform, neat polo/rugby style top or jackets and pale coloured Jodhpurs or moleskins.
14. Correct "standards" numbered helmets must be worn as specified in PCAV gear rules. Spot checks may occur and incorrect helmet will mean elimination of rider.
15. Queries, protests, horse abuse as per the PCAV Handbook of By-Laws.
16. **Dogs are prohibited without exception.**
17. PCAV Alcohol Policy applies.
18. Camping is permitted from 2pm Saturday 5<sup>th</sup> November. Fee must be paid with entry. Please be aware that there is no power or showers at the grounds. Portable yards must be of solid construction as per PCAV rules.
19. PCAV Lunging Policy applies. Lunging is permitted in the round yard only and a 15min time limit applies per horse.
20. Neither the organising committee of this competition nor the PCAV or the HRCVA accepts any responsibility whatsoever for any accident, damage, injury or illness to horses, riders, ground spectators or any other person or property.

**Start time 9:30am**

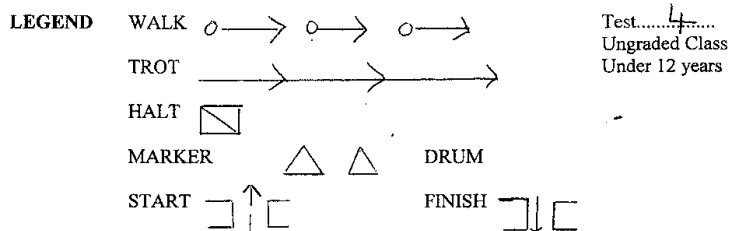
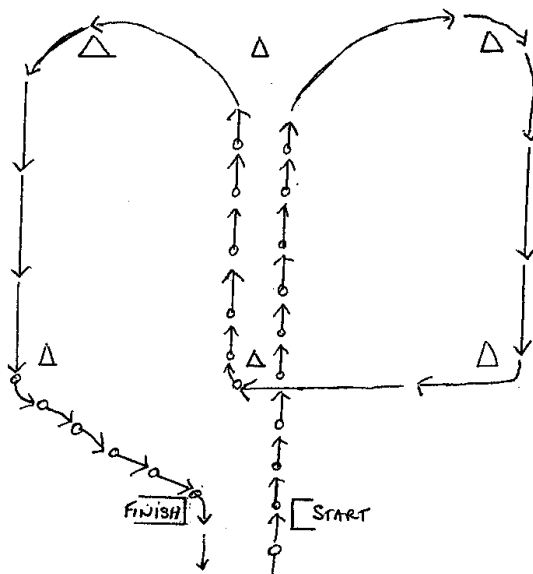

80% of total marks should cover the judgement of the Riding.
